Illinois State Board of Education provides Educator Preparation Providers (EPPs) with data licensure requirements: edTPA and content tests – both administered through Pearson. Throughout the 2022 reporting year, the emergency declaration due to public health crisis issued by the Governor of Illinois impacted these two state licensure exams. The edTPA was waived as a licensure requirement. The requirement for passing content tests prior to the student teaching semester was also waived. However, it was still a requirement to become a licensed teacher.

The Title II information below provides the Content Tests Assessment Pass Rates of program completers as defined by the U.S. Department of Education for the three previous academic years. During this three year academic period, content tests for many programs were being updated/revised. When a new test for a content becomes available, the old test does not expire for two years. Thus, candidates may choose which version of the test they would like to take.
