- I. CALL TO ORDER: S. Pancrazio called the meeting to order at 3:00 in DeGarmo 551.**
  
- II. MINUTES: L. Herschberger made a motion to approve the minutes from November 10 and November 17 meetings. B. Broad seconded the motion. Motion carried.**
  
- III. ACTION ITEMS:**
  - A. Curriculum Committee: P. Crowley**

- 1. S. Pancrazio introduced the discussion of the "Credit/No Credit" option for student teaching. The Kinsella and Stutheit report was discussed by its authors. (The report was distributed to CTE members before the meeting.)**  
**Approximately 87-88% of the grades awarded in student teaching are A's. The literature search indicated a move away from grades and toward other forms of assessment, according to Kinsella. A majority of the top twenty colleges and universities in terms of number of teachers produced have moved away from grades. Several Illinois universities have also adopted a credit/no credit, or a satisfactory/ unsatisfactory system. Schools that employ many of our graduates would not place a barrier on the employment of candidates from an "ungraded" student teaching system at Illinois State. The authors of the report recommended that Illinois State move toward a new binary system of assessment in student teaching. Discussion followed regarding training, discrimination among the exceptional, average, or below-average student, and whether student teaching should be included in the Performance Assessment Task Force or dealt with by a separate committee. CTE accepted the report and called for the Performance Assessment Task Force to come back to CTE with further recommendations about the character of student teaching assessment.**

**B. University Liaison and Faculty Concerns Committee: L. McBride.**

**L. McBride called a committee meeting for January 26, from 3:00-3:45.**

**C. Student Concerns Committee: S. Zielinski.**

**S. Zielinski reported that the Academic Competition was completed and winners are being notified. The winners will be announced at the Founder's Day Ceremony on February 15. CTE will meet on February 2<sup>nd</sup> in the University Gallery to view the submitted artwork.**

**1. Alumni Survey: R. Chaudhari**

**R. Chaudhari gave the background and overview of the alumni survey conducted with COE graduates and results. Discussion followed regarding possible questions to add, questions to clarify, and the possibility of distinguishing different programs. S. Pancrazio invited other teacher education programs to join the COE in this annual follow-up survey. She inquired into CTE's interest in participating in this survey this year. The deans' representatives are to report back to S. Pancrazio as to their interest.**

- I. CALL TO ORDER: S. Pancrazio called the meeting to order at 3:00 in DeGarmo 551. Before proceeding on to the agenda, the chair recognized and welcomed a new member to CTE. Amanda Giorno has been selected to replace the undergraduate student representative, Laura Kukuck, who resigned recently due to academic conflicts.**
  
- II. MINUTES: L. Herschberger made a motion to approve the minutes from the January 19<sup>th</sup> meeting. B. Broad seconded the motion. Motion carried.**
  
- III. ACTION ITEMS:**
  - A. Curriculum Committee: P. Crowley**
    - 1. SED 454 Consultation and Collaboration in Special and General Education: P. Crowley stated this course will provide to students the needed information and the special needs necessary which SED has wanted to provide students for a long time. On**

**behalf of the Curriculum Committee, P. Crowley made a motion for recommendation of course approval. B. Keyser seconded the motion. Motion carried.**

**1. FOR 350 Foreign Language Testing and Assessment and**

**3. FOR 355 Elementary School Foreign Language Methods: R. Dammers gave a brief explanation and made the discernment between the two courses. R. Dammers made a motion for approval. M. Kelly seconded the motion. A question was presented in regards to the credit/no credit assessment in connection to graduate students who might take the courses. R. Dammers explained graduate students will not be able to take it for credit/no credit, but will have to receive a letter grade. Motion carried.**

**4. Recommendations on Curriculum for Teaching Students with Disabilities:**

**P. Crowley circulated a handout summarizing the discussion and the recommendations deliberated at the committee's February 9<sup>th</sup> meeting. P. Smith had been invited to the meeting in order to solicit her advice as Chair of the Special Education Department. As a result, it was recommended that a special course be developed by SED as a potential dedicated course to address the future needs of teacher candidates in this area. In March, the committee from SED will bring forth the course proposal to the CTE Curriculum Committee. The CTE Curriculum Committee will then examine the proposal and make recommendations to the CTE. It is likely that all teacher education programs will be asked to consider adopting it or to show how its**

**courses already address the course objectives and materials. Discussion/questions followed. CTE Curriculum Committee is requested to proceed and report back.**

**B. University Liaison and Faculty Concerns Committee: L. McBride.**

**No report.**

**C. Student Concerns Committee: S. Goodwin in the absence of S. Zielinski**

**S. Goodwin announced the winners of the written essay contest and the visual arts contest of the Academic Competition. He also commented on the appropriate connection the recognition of the winners made regarding the Founder's Day ceremony. The two first-place winners and the two second-place winners were awarded \$1,000 and \$500 each, respectively.**

**Efforts are being made to obtain external resources to support this project in the future.**

**S. Pancrazio assigned the Student Concerns Committee the task of reviewing a draft set of procedures to see if they are appropriate for this Council to use if the need for a hearing to a TERB appeal would ever arise. It was recommended that a Student Concerns Committee meeting be scheduled on March 16 at 2:00.**

**A. Alumni Survey: Feedback from Colleges**

**CTE needs to determine how to conduct alumni follow up since NCATE requires ISU to do so. A commitment from departments is needed if departments wish to collaborate with the COE or whether they wish to conduct their own. S. Pancrazio requested the deans' designees to call her. It is noted this item is to be a carry-over item for CTE's next meeting.**

**I. INFORMATION ITEMS:**

**A. Items to be discussed:**

**1. TERB Procedures and Records of complaints:**

**S. Pancrazio requested members to review page 7 and 8 of the CTE Bylaws regarding Teacher Education Review Board. It was noted that the function of TERB, as described in the bylaws, addresses complaints about admissions, evaluation, and certification. A lengthy discussion followed. Whereas, three primary concerns were brought forth: (1) How to clarify the confusion for students as to where the appeal should be started. (2) Is there an appeal after CTE? (3) Is the Executive Committee a proper body to hear appeals as opposed to one of the other three CTE committees or even, perhaps, a new configuration of a special committee?**

**P. Smith suggested policies and procedures need to be in writing. S. Pancrazio directed this be a continuing item for discussion purposes and requested M. Shaw-Baker to provide further information about the waiver form in use.**

**C. Student Concerns Committee: S. Zielinski**

**S. Zielinski requested to table discussion related to AACTE resolutions until her committee has more time to discuss the resolution related to program administration.**

**S. Zielinski then led a discussion on TERB and its place in the bylaws. Her committee is studying proposed standardized language**

for pamphlets, bylaws, and the Student Handbook. Discussion followed. The Format for Council for Teacher Education Hearing document was amended as follows:

(1) Prior to the Hearing: #4 is to be added to the end of #6. #6 thereby becomes #4. (2) At the Hearing: #9, last sentence: Delete "Chair of CTE" and replace with "Director of Clinical Experiences and Certification Processes or an appointed designee". As amended a motion was made by T. Haynes; seconded by M. Moore. Motion carried.

Amendment moved "At the Hearing #2": to delete the phrase "members of the specific student's department". Motion made by S. Zeck and seconded by P. Smith. Discussion followed. Amendment failed, 11-2.

Amendment moved to reword "At the Hearing #2" to read as: "... of the specific student's department and/or members of TERB may not be present at the hearing ..." Motion was made by P. Smith; seconded by S. Zeck. Motion carried 11-2.

Amendment moved to "At Hearing #2" which should read as follows:

The Chair of CTE will facilitate the hearing but will not vote and will not participate in the deliberations. Other members of the CTE who may be members of the specific student's department and TERB members may not vote on the final decision nor participate in the deliberations of the Council. Motion made by P. Smith and seconded by S. Zeck. Motion carried unanimously.

Main motion called as revised and amended on March 16, 1999. Motion carried with one abstention.
